

TERMS AND CONDITIONS (T&C)

1. This T&C shall be applicable for all contests/activities which will be conducted on the channel "Epic Music ("**Channel**")", whether current or future. The contest/activities are applicable across the Channel and are not limited to any specific show ("each a **Contest**").
